**Coronavirus State and Local Fiscal Recovery Funds:** Discussion was held about the possible uses for the State and Local Fiscal Recovery Funds (provided by the American Rescue Plan Act). Clerk-Treasurer Murray will follow up on appropriation guidelines from the Treasury at the next meeting.

**Fire Department:** Trustee Cuykendall motioned to approve new Fire Department member Chase Scutt. Trustee Radford seconded the motion. All members present voted aye. Motion passed.
